THE EDUCATION PROGRAMME AT THE CRACOW UNIVERSITY OF TECHNOLOGY DOCTORAL SCHOOL in the discipline of Architecture and Urban Sciences within the framework of cooperation with FH Münster University of Applied Sciences (FH Münster) effective since the academic year 2023/2024

L

General provisions

- The education programme of the Cracow University of Technology Doctoral School, hereinafter referred to as the Doctoral School or the CUT DS, has been developed pursuant to the act *Law on Higher Education and Science* of the 20th July 2018 (J. of L. of 2022, item 574, as amended), *the Act* of the 22nd December 2015 *on the Integrated Qualifications Systems* (J. of L. of 2018, item 2153) and *the Regulation of the Minister of Science and Higher Education* of the 14th November 2018 *on the second degree characteristics of learning outcomes for levels 6 – 8 qualifications according to the Polish Qualifications Framework* (J. of L. of 2018, item 2218), as well as pursuant to the bilateral agreement concluded between Cracow University of Technology and FH Münster University of Applied Sciences, hereinafter referred to as FH Münster.
- Education at the CUT DS offered in cooperation with FH Münster is provided in the discipline of Architecture and Urban Sciences, in which Cracow University of Technology is entitled to confer academic degrees.
- 3. The education programme is approved by the Senate upon the motion of the CUT DS Head. The list of modular courses is approved by the President of the Scientific Council of the discipline of Architecture and Urban Sciences.
- 4. The education cycle at the CUT DS offered in cooperation with FH Münster lasts 6 semesters.
- 5. The instruction at the CUT DS offered in cooperation with FH Münster may be delivered in English, Polish or German.
- 6. The number of ECTS points assigned to the education programme at the CUT DS offered in cooperation with FH Münster is at least 40 ECTS.
- 7. The number of ECTS points required to be obtained by doctoral students at FH Münster is at least 60 ECTS.
- Doctoral students obtain at least 20 ECTS points, out of 40 ECTS points required to complete the education programme at CUT DS, for courses conducted at Cracow University of Technology.
- Doctoral students may obtain no more than 20 ECTS points, out of 40 ECTS points required to complete the education programme at CUT DS, for courses conducted at FH Münster, approved and listed in this CUT DS education programme and featured in the eHMS system of Cracow University of Technology.

- 10. Doctoral students obtain the 20 ECTS points which constitute the difference between the number of points required of doctoral students at FH Münster (60 ECTS points) and the number of points required at CUT DS (40 ECTS points obtained jointly at CUT DS and FH Münster) at FH Münster, pursuant to separate regulations and the education programme effective at FH Münster.
- 11. The courses featured in the education programme at CUT DS offered in cooperation with FH Münster are mandatory, with the possibility of selecting some courses for which such option has been provided.
- 12. Detailed rules for achieving the learning outcomes and the forms of their evaluation have been specified in the syllabuses of individual courses.
- 13. Completion of the education programme of the CUT DS offered in cooperation with FH Münster is possible within the framework of the Individual Organisation of the Education Process, in compliance with the CUT Doctoral School General Regulations.
- 14. Completion of the education programme of the CUT DS offered in cooperation with FH Münster leads to the achievement of the learning outcomes reflecting the general characteristics of learning outcomes for the level 8 qualification of the Polish Qualifications Framework specified in the effective regulation of the Minister of Science and Higher Education of the 14th November 2018 on the second degree characteristics of learning outcomes for levels 6 8 qualifications according to the Polish Qualifications Framework (J. of L. of 2018, item 2218).
- 15. The doctoral student's education cycle at the CUT Doctoral School, in cooperation with FH Münster, ends with the submission of their doctoral dissertation at Cracow University of Technology.
